<u>HOLD HARMLESS</u> Releasor will hold harmless Association, its directors, officers, members, owners, employees, agents, representatives, lessees, insurers, and administrators, from any and every claim, demand, action, suit or right, of whatever kind or nature, in law and equity, for bodily injury, personal injury, death, and property damages arising out of, caused by, or resulting from any accident, incident or occurrence related to participation in water skiing, other water sports, other related activities, any other activities on the premises, and the use of equipment, whether or not by the negligence of Association, its directors, officers, members, owners, employees, agents, lessees or representatives.

This Release includes claims, demands, actions, suits or rights, of whatever kind or nature, for bodily injury, personal injury or death on account of first aid or medical treatment provided to Releasor, or the failure to provide first aid or medical treatment to Releasor.

This Release contains the entire agreement between Releasor and Association. The terms of the Release are contractual and not mere recitals. This Release continues in full force and effect unless revoked in writing.
